This Waiver shall be deemed as a release, waiver, discharge, and covenant not to sue MCPL. I further understand and agree that this Waiver, release and assumption of risks is to be binding on my heirs and assigns.

It is my express intent that this Waiver shall bind members of my family, heirs and/or representatives, if I am deceased. This Waiver shall be deemed as a release, waiver, discharge, and covenant not to sue MCPL.
